



# **Privacy Policy**

### Introduction

#### **3. Information Sharing**

• With Third Parties: We do not share your personal or credit information with third parties except as necessary to provide our services, comply with legal obligations, or with your explicit consent.

• With CICs: We share your personal information with CICs to obtain your credit report as per the authorization you provide.

#### 4. Security of Your Information

We take the security of your personal and credit information seriously and implement industry-standard measures to protect it. These measures include encryption, access controls, and regular security audits.

#### 5. Your Rights
